Dear Superintendent Grego:

The Florida Department of Education (FDOE) annually collects comparability reports from local educational agencies (LEAs) that demonstrate the use of state and local funds, which provide services to Title I schools that are comparable to those provided to non-Title I schools. If the LEA serves all its schools with Title I funds, the LEA must use state and local funds to provide services that, taken as a whole, are substantially comparable in each Title I school. In order to receive Title I, Part A funds, LEAs are required to demonstrate compliance with the comparability requirements: (1) preparing comparability calculations, if applicable; (2) identifying Title I schools that are not comparable and describing action(s) to be taken to make them comparable; and (3) submitting the requisite information to FDOE.

The United States Education Department (USED) requires that a state educational agency (SEA) biennially review the source documents a LEA uses to conduct its comparability calculations. Those LEAs that were required to submit source documents to support the data reported for 2013-2014 school year are attached.

Local Educational Agencies that were required to only complete the online comparability report for the 2013-2014 reporting period should keep in mind that the LEA's online report was reviewed and approved based solely on the data and the written procedures provided in the online system. The LEA is required to maintain evidence that it conducted comparability calculations and can document that all schools were indeed comparable in the event of a review of the LEA's actual source documents. If a school's online reports are not supported by the evidence in their actual source documents, they will be found in non-compliance.

The FDOE is in receipt of your LEA's comparability report and supporting documents. The Bureau of Federal Educational Programs staff reviewed each LEA's documents and determined that each LEA demonstrated compliance with comparability requirements for the 2013-2014 school year.
