MAJOR FUNCTION

This position assists the school's administrator with oversight and operation of the day and evening adult education center personnel and programs.

- Assists adult education center administrator with supervision of the school in the absence of the adult education center administrator
- Prepares day and evening schedules for all adult education, self-sustaining, and career/technical classes
- Monitors student intake processes including guidance services, testing, and class assignment
- Provides and facilitates professional development to adult education teachers as needed
- Works with adult education center administrator and other school personnel to facilitate consistency between day and night operations
- Assists adult education center administrator with grant responsibilities
- Collaborates with district curriculum and program personnel
- Assists adult education center administrator with development supervision and operation of off-site programs
- Assists adult education center administrator with marketing and recruiting
- Assists adult education center administrator in conducting faculty meetings
- · Assists adult education center administrator in developing the school's master schedule
- Assists adult education center administrator in securing and managing textbooks and other instructional supplies
- Assists the adult education center administrator in ensuring the schools' master discipline plan is implemented
