

**SCHOOL BOARD OF PINELLAS COUNTY, FLORIDA**  
**WORKSHOP – November 17, 2015**

The School Board of Pinellas County, Florida, conducted a workshop on Tuesday, November 17, 2015, at 11:49 a.m., in the Cabinet Conference Room, Administration Building, 301 4<sup>th</sup> Street SW, Largo, Florida.
