**MAJOR FUNCTION:**

Under general supervision, coordinates accurate and timely payments to insurance carriers and tax deferred annuity vendors. Resolves employee and carrier/vendor inquiries and complaints. Audits files for compliance with various governmental rules and regulations and school board policies and procedures. Responsible for analyzing, updating and producing reports.

**DUTIES AND RESPONSIBILITIES:**

- Coordinates accurate and timely payments to insurance carriers and tax deferred annuity vendors.
- Analyzes, calculates, reconciles and balances payments each month.
- Answers questions and resolves employee and carrier/vendor inquiries, complaints, and discrepancies.
- Analyzes, updates and produces reports.
- Maintains open communications with employees and coordinates termination insurance adjustments through payroll.
- Coordinates cut-off schedule with Data Processing, Accounting, and Payroll for reporting and paying carrier payments, processing adjustments, etc.
- Provides technical assistance to other employees on complex employee insurance adjustments.
- Assists superiors with training.
- Writes and types informational memos to appropriate parties regarding payments, coverage changes, arrears, refunds, insurance status, etc.
- Coordinates daily processing of tasks associated with 403B plan, COBRA and dependent day care.
- Assists superiors as needed.
- Performs other related duties as required.

**MINIMUM QUALIFICATIONS:**

Associate's degree in Accounting or Business Administration plus three (3) years of experience performing most of the duties stated above. Demonstrated proficiency in computer literacy.

Bachelor's degree preferred.
