ELECTRONICS TECHNICIAN

MAJOR FUNCTION:

Performs semi-skilled work in the maintenance, repair and installation of a wide variety of safety and non-safety related electronics equipment containing analog, digital and/or microprocessor-controlled circuitry. Assists Electronics Technician-Journeyman with major projects and performs minor repair and installation tasks with minimal supervision. Work is reviewed in progress or upon completion through observation and results obtained.

DUTIES AND RESPONSIBILITIES:

- Assists Electronics Technician-Journeyman in the on-site maintenance repair and installation of safety and non-safety related electronic equipment and systems including one or more, but not limited to the following: clocks, bells, and sprinkler system timers, intercoms, sound distribution equipment, closed circuit television, scoreboards, public address systems, cable distribution systems, telecommunication systems, and intrusion/security access systems.
- Assists in analog, digital and/or microprocessor-controlled equipment/systems inspections as required.
- Performs related bench repair activities such as testing, repairing and replacing defective electronic components and circuits; rebuilding printed circuit boards, soldering and de-soldering connections.
- Assists in maintenance and repair involving solid-state integrated circuit devices, electronic relays and/or signal transmitters.
- Applies knowledge of testing instruments and tools of the trade such as oscilloscopes, ammeters, voltmeters, and signal generators. Also applies knowledge of occupational hazards and safety precautions in the performance of job duties.
- Works from diagrams and sketches; carries out written and oral instructions; maintains appropriate records, such as daily work logs, as required.
- Erects and works from scaffolding where needed; climbs and works from ladders and lifts and moves
 equipment on a regular basis.
- Performs related work as required.

MINIMUM QUALIFICATIONS:

Graduation from high school or possession of a GED, plus three (3) years experience in maintenance, repair and installation of one or more of the following types of electronic equipment: clocks, bells, and sprinkler system timers; intercoms; TV and sound distribution equipment; and/or fire alarms; performing most of the above duties and responsibilities. The successful completion of up to two (2) years of verifiable formal training in the trade (vocational, military, or indentured apprentice school) may be substituted for a like amount of the experience requirement. Possession of a valid State of Florida Class E noncommercial driver's license and any other license as may be required by law.

PREFERRED:

Certification as an associate level Certified Electronics Technician plus three (3) years progressively responsible work experience related to the duties and responsibilities.
