PEST CONTROL TECHNICIAN

MAJOR FUNCTION:

Performs manual and technical duties in carrying out investigative, preventive, and corrective pest control services in School Board facilities. Work includes, but is not limited to, control and removal of rats, possum, pigeons, bats, roaches, ants and termites. Work is performed under general direction, with considerable independence, and is reviewed through reports, conferences and inspections.

DUTIES AND RESPONSIBILITIES:

- Inspects schools and facilities to detect pest problems; determines and implements appropriate methods and procedures to be used for control and/or removal.
- Selects, mixes, and applies chemicals and pesticides to designated areas of facilities; assists with testing of chemicals for suitability prior to purchase.
- Climbs into attics and crawls under buildings for removal of rodents and other mammals or birds by hand or through the use of baits, traps, and/or foggers.
- Drills holes for treatment of subterranean termites and applies appropriate chemicals; identifies dry wood termite damage and coordinates tent fumigations with outside contractors.
- Treats lawns, fields, trees, shrubs, and other outside areas for pest problems such as fire ants and mole crickets.
- Is responsible for the safe storage and disposal of toxic chemicals; cleans, inspects and maintains equipment such as spray tanks and pumps.
- Maintains records of chemical usage and paperwork on treatments and inspections.
- Applied knowledge of life cycles, habits and habitats and of pest control methods, techniques, procedures, hazards and safety practices in performance of job duties.
- Keeps abreast of current developments in pest control methods and procedures through attendance of classes and seminars.
- Performs related work as required.

MINIMUM QUALIFICATIONS:

Graduation from high school, vocational school, or possession of a GED, plus two (2) years progressively responsible work experience related to pest and rodent control. Possession of a valid State of Florida Class E noncommercial driver's license. Must acquire and maintain a current Public Health Pest Control certificate license issued by the Florida Department of Agriculture which covers Core, Structural, and Ornamental/Turf within six (6) months of placement into the position.
