# **REGISTERED PHYSICAL THERAPY ASSISTANT**

#### **MAJOR FUNCTION:**

Implements an effective physical therapy program based on knowledge of etiology, characteristics, and prognosis of conditions, treatment techniques, and developmental sequences. Assists in developing therapy treatment plans, evaluates progress, decides on treatment modifications and prepares analytical progress notes. Work is performed under direction of a registered physical therapist in accordance with State licensure procedures and is reviewed in progress through observation and upon completion through conferences and reports.

## **DUTIES AND RESPONSIBILITIES:**

- Assists in assessing student's level of functioning and need for therapy.
- Assists in developing Individual Educational Plans (IEPs) for each eligible student, and participates in the IEP meetings, at the direction of the registered therapist.
- Implements therapy programs developed by the registered therapist to meet IEP goals and objectives specific to the functional needs and impairments of the student.
- Provides treatment techniques that include, but are not limited to, activities that promote postural and gross motor development, gait and motor trainings, guidance and use of adaptive equipment, and exercises to enhance functional performance.
- Demonstrates and models techniques and specific programs to parents, teachers, teacher assistants, or other appropriate personnel, as prescribed by the registered therapist.
- Collects and records data on therapy programs.
- Monitors therapy programs through observation and data.
- Maintains accurate records.
- Assists with preparation of progress notes to parents and physicians.
- Manages student behavior during therapy.
- Lifts, carries, and positions students, where applicable.
- Escorts students from and to classes as needed for student participation in therapy.
- Develops and adheres to daily schedule.
- Requests and/or orders appropriate materials and equipment; uses and maintains them.
- Recommends appropriate adaptations to the learning environment.
- Participates in meetings, conferences, and on committees, as directed.
- Attends scheduled meetings and workshops for professional growth and staff development.
- Performs related work as required.

## **MINIMUM QUALIFICATIONS:**

Graduation from a physical therapy assistant school approved by AMA in collaboration with the American Physical Therapy Association. Associate Degree in Physical Therapy. Hold or be eligible for Florida Physical Therapy Assistant license.
