# TRANSPORTATION ROAD SAFETY SPECIALIST

### **MAJOR FUNCTION:**

Provides continuous on-the-road monitoring of all aspects of driver performance and compliance with all safety related rules, regulations, and statutes that pertain to school bus driver's and operation of school buses.

#### **DUTIES AND RESPONSIBILITIES:**

- Handles complaints from local law enforcement, school based administrators and the public at large regarding unsafe driving practices on the part of school bus drivers.
- Audits and analyzes arrival, layover, and departure times of buses, student load data and other related information.
- Audits school bus routes, stops, equipment, and drivers to promote safety and efficiency.
- Takes immediate corrective action with drivers to remedy significant/fatal safety deficiencies when
  observed.
- Works cooperatively with Supervisor, Transportation Field Operations and Manager, Transportation
   Area to resolve performance issues and/or to take appropriate disciplinary action.
- Reports on and recommends routing, scheduling, and related changes that ensure the safety of customers and efficiency of the transportation system.
- Ensures compliance with Federal and State statutes, rules, and regulations and Pinellas County School Board policies and rules pertaining to transportation of students.
- Coordinates with appropriate personnel in Transportation, district offices and governmental agencies regarding safety issues pertaining to transportation of students.
- Maintains detailed records of route/driver observations to document and provide relevant statistics and related information regarding students transported and transportation services provided.
- Performs routine on-site checks of bus stops, for compliance of policy and procedures.
- Ensures drivers apply policy and procedures by riding the school bus.
- Performs other related duties as required.

## **MINIMUM QUALIFICATIONS:**

Graduation from high school or possession of a GED, supplemented by some college level courses and three (3) years transportation experience. Possess and maintain a valid Florida class "B" commercial driver's license with passenger and school bus endorsements.

#### PREFERRED:

Associate's or Bachelor's degree in business or related fields and demonstrated knowledge of state and local laws and regulations regarding the operation of public school buses. Evidence of a working knowledge of computerized bus routing systems.
