TURF MAINTENANCE TECHNICIAN

MAJOR FUNCTION:

Performs technical work in the maintenance of athletic fields and grounds in accordance with accepted practices and methods of turf and grounds maintenance. Duties are varied and may include minor supervisory responsibility as it relates to the maintenance of athletic fields.

DUTIES AND RESPONSIBILITIES:

- Leads and directs school-based groundskeepers as it pertains to athletic turf grass.
- Performs basic maintenance of athletic fields which includes mowing, watering, aerating, verticutting, top dressing, seeding, and sodding.
- Applies and calibrates fertilizers, herbicides, and pesticides in the maintenance of athletic field turf grass utilizing knowledge of the functions and hazards of the various types of these chemicals and the rules and regulations governing their application.
- Takes soil samples, analyzes soil reports, and establishes corrective measures where needed.
- Diagnoses insect and disease problems and takes corrective action.
- Operates, maintains, and makes minor repairs to light and heavy equipment necessary for the maintenance of athletic turf grass such as tractors, sprayers, spreaders, aerators, reel mowers, and verticutting equipment.
- Tows or hauls turf maintenance equipment to job site.
- Repairs irrigation systems and replaces minor irrigation components.
- Performs other related duties as required.

MINIMUM QUALIFICATIONS:

Graduation from high school or possession of a GED and technical school training which includes courses in Horticulture plus five (5) years of progressively responsible experience in a related field or an equivalent combination of education, training, and experience. Possession of a valid State of Florida Class E noncommercial driver's license. Must obtain Pinellas County certification for dispensing pesticides and herbicides.
